Comments: The year of construction was verified as 1973 per Sarasota County Property Appraiser.
- 2. Roof Covering:** **FBC Equivalent**
Comments: The roof covering was replaced in 2017. The roof permit was confirmed and the permit number is 17 108343 00 BE. This roof was verified as meeting the building code requirements outlined on the mitigation affidavit.
- 3. Roof Deck Attachment:** **Level C**
Comments: Inspection verified 1/2" plywood roof deck attached with 8d nails at a minimum 6" on the edge & 6" in the field.
- 4. Roof to Wall Attachment:** **Clips**
Comments: Inspection verified hurricane clips fastened with a minimum of three nails.
